General overview:

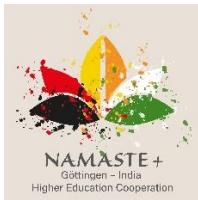
The Georg-August-Universität Göttingen (UGOE) offers scholarships for **outgoing student mobility (Bachelor, Master, PhD)** for studying and research at the above listed Indian higher Education Institutions for the second term 2020. The scholarships are open to all academic areas.

The deadline for submission of the applications is December 1, 2019

*The scholarship will be paid only for the duration of the semester at the Indian university



Travel: Travel (round trip economy class flight) will be organized by the grantee him/herself, and will receive from the Namaste+ team a lump sum of 1075€ for travel costs.

Insurance: All grant holders have the opportunity to be insured by a central Group Insurance, which will be centrally organized by the NAMASTE+ Team upon successful nomination and request from the grantee. The insurance costs (approximately 0,99 EUR per day) are deducted from the individual support.

- Letter of Reference from coordinator at the Home University
- In the case of PhD applicants: Invitation letter from the Host University - which means the candidates should have contacted their prospective supervisor or collaborator
- CV
- Academic certificates as requested in the online form

Eligibility criteria

- Quality of the application (clearly defined goals and expected outcomes, expected impact, methodology, fitness for the project's objectives, schedule)
- Aptitudes (such as intercultural readiness, interpersonal skills and problem solving)
- Qualifications (academic, competences, publications, relevant prizes, etc.)
- Language skills
- Impact and relevance for India/ Germany (especially in mutual research interest, PhD mobilities)

Required language skills: Good knowledge of English (B2 – C1)
